
STEP 1 - Security Box to Mounting Bracket





Put on safety glasses. Place Mounting Bracket upside down onto a flat surface. Insert M6 Hex Head Bolt and Flat Washer through mounting holes (Fig1). Flip Under Seat Security Box over and align mounting tabs with corresponding holes on Mounting Bracket. Attach M6 Flat Washer and M6 Nylock Nut to M6 Hex Head Bolts (Fig2)

STEP 2 - Security Box to Mounting Bracket





Flip assembly over and center Security Box in Mounting Bracket slotted mounting holes (Fig3). Using M10 wrench, M10 socket and ratchet secure Under Seat Security Box to Mounting Bracket using supplied M6 Nylock nut, washers and bolt. (Fig4).



STEP 3 - Vehicle Preparation





Slide front passenger seat fully forward. Remove any loose articles from around and under back side of passenger seat (Fig5). Remove floor mat or floor liner. To be reinstalled later (Fig6).


STEP 4 - Seat Bolts





Using T50 Torx socket loosen and remove the two rear seat mounting bolts securing seat base to floor. Do Not Discard T50 Torx bolts. They will be reinstalled in step 5 (Fig7). With bolts removed lift back of seat up and slide Under Seat Security Box assembly under seat brackets (Fig8).

STEP 5 - Securing Assembly to Vehicle





Place Security Box Mounting Bracket under seat mounting bracket. Align seat mounting bracket holes with Security Box Mounting Bracket holes and reinstall factory T50 Torx bolts removed in step 4 (Fig9). Using T50 Torx socket tighten seat mounting bolts and torque to 45ftlbs (Fig10).

STEP 6 - Operation and Use





After installation confirm proper seat function. Seat should slider fully forward and fully back without interference. Confirm proper key and drawer operation (Fig11). Reinstall floor mat or floor liner (Fig12).

What is Covered:
